## APPLICATION FOR DISPENSATIONS/PERMISSIONS

We petition the Most Reverend Bishop:

I. TO GRANT DISPENSATION from the following impediment:

- ☐ Disparity of Cult (c. 1086 § 1) [Unbaptized]
- ☐ Disparity of Cult *ad cautelam* (c. 1086 § 1) [Validity of Baptism Doubtful]
- ☐ Other [ e.g., consanguinity (cc.1091, 108); affinity (cc.1092, 109); adoption (cc.1094,110)]  
[Deacon to receive the vows in a Nuptial Mass]

II. TO GRANT PERMISSION for marriage in the following situation(s):

- ☐ The Catholic party wishes to marry a baptized non-Catholic in accord with cc. 1124-1125, 1127 §1.
- ☐ \*\* One or both of the parties is bound by the natural obligations toward another party or toward children, arising from a prior union (c. 1071 §1.3°).

## FOR THE GRANTING OF DISPENSATIONS/PERMISSIONS

In accord with canon 1125, in order to grant the dispensation(s) and /or permission(s) for a Catholic party to marry a non-Catholic,

The following three conditions are to be fulfilled: (1) the Catholic party makes the Mixed Marriage promise below; (2) the non-Catholic party is informed of said promise and obligations; (3) both parties are instructed about the purposes and essential properties of marriage, the priest/deacon/pastoral minister attests to these by signing below, noting the date and place and using the parish seal.

### Mixed Marriage Promise

Experience has shown that there can be certain dangers in a marriage in which the religious belief of the spouses is different. Individuals can fall away from the practice of their faith, and children may become victims of spiritual indifference and neglect.

In order to give assurance that these dangers do not exist in the case of this proposed marriage, the priest/deacon/pastoral minister is directed to discuss with both parties the responsibility of the Catholic, resulting from the very nature of his/her Catholic faith and conscience, to share this faith with his/her children by baptizing and providing instruction in the Catholic faith. The declaration and promise required of the Catholic party shall be made in the following words:

**I reaffirm my faith in Jesus Christ and, with God's help, intend to continue living that faith in the Catholic Church. At the same time I acknowledge the respect I owe to the Conscience of my partner in marriage. I promise to do all in my power to share the faith I have received with our children by having them baptized and reared as Catholics.**

## DISPENSATION FROM CANONICAL FORM FOR A MIXED MARRIAGE

Note: this is to be requested only when the ceremony (1) will not take place in a Catholic Church, Catholic chapel or Catholic oratory, and (2) will not be celebrated by a Catholic clergyman.

A Dispensation from Canonical form must always originate in the parish and diocese in which the Catholic Party has a domicile, regardless of the city or diocese where the ceremony takes place. The pre-nuptial file remains in the originating parish and the marriage is to be recorded in the Marriage Register of that parish.
